Introduction

Background

BioNET-NAFRINET (www.bionet-nafrinet.net)

The North African Network of Taxonomy is a LOOP (Locally Owned and Operated Partnership) of BioNET-International (www.bionet-intl.org) established in 2003 upon a proposal made to governments of the region.

Objectives of BioNET-NAFRINET

To establish and support within the north-African subregion a realistic autonomy, in infrastructures, human resources and taxonomical services in response to a request from countries at the 6th Conference of Parties of the Convention on Biological Diversity (CBD) to overcome the « **Taxonomic Impediment**» (CBD Decision VI/8). In particular:

1. To enable the achievement of national and subregional objectives in the development of sustainable management of all biological resources and ecological systems
2. To strengthen existing centres of expertise and establish new facilities, capabilities and resources so as to provide the region with the appropriate infrastructure and cadre of taxonomists needed to ensure self-sufficiency and self-reliance in taxonomy.
3. To conduct training, rehabilitate collections and develop and maintain records, develop user-friendly aids for identification, and transfer information and technology under donor supported institutional strengthening and capacity-building programmes.
4. To assist North African countries to meet their commitments to the Convention on Biological Diversity, and other relevant international conventions, protocols and initiatives, particularly the International Plant Protection Convention (IPPC), Convention to Combat Desertification (UNCCD), Barcelona Convention, CITES, RAMSAR and Agenda 21.
5. To provide individual member governments, international organisations, NGOs, IGOs and donors, with a taxonomic structure and focal points within the sub-region and each country in order to facilitate economies of scale, and provision of the best possible advice on taxonomic matters, and the best possible taxonomic services in support of their programmes

Main workshop observations & findings

- LCC meeting has been scheduled after an International Conference on “Taxonomy and Biodiversity” organized by the ATUTAX, the Tunisian Association of Taxonomy;
 - All LCC Participants were also invited to the 1st ATUTAX International Conference
- Were not able to attend:
 - CBD/GTI NFPs from Algeria, Egypt, Libya, Mauritania, Morocco and Tunisia were not able to attend the LCC meeting; however:
 - Egypt was represented by Dr. Taher Issa from the Egypt Environment Agency;
 - Libya was represented by Mr Saleh Mohamed Amnissi;
 - Mauritania was represented by Mr Ahmed Ould Abdel Vettah;
 - Tunisian CBD NFP, Mr Nabil Hamada, presented Tunisian situation at the ATUTAX Conference;
 - Pr Eckhard von Raab-Straube (Euro+Med PlantBase, Germany) was not able to attend due to air traffic problems in North Europe and USA;
 - Pr Mohamed Neffati (IRA, Medenine) was not able to attend;
- Mauritania endorsed BioNET-NAFRINET on April 7th, 2010; country members of BioNET-NAFRINET are now five/six: Algeria, Egypt, Mauritania, Morocco and Tunisia;
- Libya may soon endorse BioNET-NAFRINET;
- Upon approval from LCC Committee members, the CBBC, Tunisia, renewed its three years mandate to be the NECI for BioNET-NAFRINET; Prof. Mohamed Elyes Kchouk is the Regional Coordinator for BioNET-NAFRINET for the period 2010-2013;
- The Ministry of Higher Education and Scientific research and the CBBC will give logistical support to BioNET-NAFRINET;
- ATUTAX bureau was invited to participate to the LCC Meeting together with guests from EAFRINET, Dr. Wanja Kinuthia, EAFRINET coordinator, European Universities and Museums, Dr. Gianniantonio Domina, Dr. Louis Boumans, and BioNET-International, Dr. John Mauremooto;
- The participation of resource persons from other regions and other biocons helped to draft the priorities for BioNET-NAFRINET for the next three years term;

Recommendations/Lessons Learned

- The organization of LCC Meeting back to back to ATUTAX International Conference was beneficial for the Network in the sense that ATUTAX bureau helped draft priorities and activities of BioNET-NAFRINET for the next three years term 2010-2013;
- ATUTAX might be the “right arm” of BioNET-NAFRINET; similar national scientific associations might be encouraged in order to help BioNET-NAFRINET at the national level;
- A monitoring agenda should be established by the NECI in order to follow up the drafted priorities and activities to be run next three years term.
